### COLO SFC: ISSUANCE OF STRIKE ONE UNDER NEPEAN FA THREE STRIKE POLICY

Thursday, 18th September, 2025

Dear Colo SFC club members,

It is with regret that Nepean FA must inform you that Colo SFC has received a disciplinary strike under the [Three Strike Policy](#). Disciplinary strikes have the potential to affect the standings of all competition teams in a club. More information about the policy and how it might affect your team and club is available by following the link.

The Strike has been regrettably issued in response to numerous incidents which have arisen throughout the year, including, but not limited to:

1. Disrespectful spectator behaviour in breach of the [FA Spectator Code of Behaviour and NFA Code of Conduct](#),
2. The disproportionately high number of Y2 cautions [dissent] issued to Colo SFC members across multiple fixtures, and
3. Additional infringements, including breaches of Nepean FA match day protocols and procedures.

Nepean FA urges all CSFC members to collaborate with the CSFC leadership team in fostering a culture of respect, fairness, and integrity for all individuals involved in the sport. This expectation extends to all interactions before, during, and after games, both on and off the field, for every player, team official, club official, parent, and spectator, regardless of whether they are at home or away fixtures.

Nepean FA encourages all CSFC members to embrace the principles and values of sportsmanship, consider their club's reputation and take necessary steps to mitigate further risks. Please be advised that the infringement notice will remain effective for a duration of 12 months.
